





- i. Total number of existing dumpsites: 02 no's, one at SIPSU Soreng District and other at Chandey Mangan District (However dumping site at Chandey, Mangan District has been stop from April 2023 and Mangan Nagar Panchayat availing the landfill facility located at Martam.
- i. Dumpsites reclaimed/capped: 01 (Chandey, Mangan District)
- ii. Dumpsites converted to sanitary landfill: 1, Martam Landfill site.
- iii. Public hearing for proposal of waste processing facility (sanitary landfill) at Ringdang, Mangan District was completed. Report has been prepared by SPCB-Sikkim and forwarded to SEIAA for further action.

Note: (i) Gangtok Municipal Corporation, under Gangtok District and Rangpo Nagar Panchayat, Singtam Nagar Panchayat located under Pakyong District and Mangan Nagar Panchayat are availing the landfill facility located at Martam, Gangtok District Sikkim. (ii) Similarly, Geyzing Nagar Panchayat, Namchi Municipal Council and Jorethang Nagar Panchayat located in Namchi and Geyzing Districts are using the dumping site located at Sipsu, Soreng District Sikkim.

ANNEXURE – I

A SUMMARY STATEMENT ON PROGRESS MADE BY LOCAL BODY IN RESPECT OF SOLID WASTE MANAGEMENT:

- Door to door collection of segregated waste is being currently practised in all of the ULBs of Sikkim through garbage collection vehicle.
- Practice of Community bins/secondary waste storage facility has been stopped but GMC has placed bins for tourist and local public in main market area.
- Construction of sanitary landfill at Ringdang in Mangan District is being taken up by UDD, Govt. of Sikkim and process of obtaining EC is currently underway.

ANNEXURE – II

A SUMMARY STATEMENT ON PROGRESS MADE BY LOCAL BODIES IN RESPECT OF WASTE COLLECTION, SEGREGATION, TRANSPORTATION AND DISPOSAL:

- Door to door collection of waste along with ringing of bell is being carried out in the ULBs of Sikkim through garbage collection vehicle.
- Segregation and collection of waste into dry and wet waste being practised in all the ULBs. Focussed IEC activities on source segregation and positive behavioural change.
- Transportation of collected waste is done by assigned covered garbage vehicles.

A SUMMARY STATEMENT ON PROGRESS MADE BY LOCAL BODIES IN RESPECT OF IMPLEMENTATION OF SCHEDULE-II:

1. The town of Mangan processes roughly about 0.2 TPD of total Solid waste generated through Organic Waste Convertor Machine. The compost generated being used by ULB itself.
2. Gangtok Municipal Corporation(GMC) at Lal market Gangtok have installed composed plant of capacity 01 TPD to convert organic waste into manure.
